November 1, 1956.

The regular meeting of the Officers, Directors and Chairmen of Standing Committees, held at the Pleasantville High School Library, was called to order by the President at 8:20 P.M.

The minutes of the regular meeting of October 4, 1956, were read and approved.

The Treasurer reported \$31.66 in the general fund and \$105.27 in the Scholarship Fund. The report was accepted.

The Program Committee reports no success in getting any statement from Mr. Vishniac about a fee for his lecture but the Board felt that he should receive some part of the return from the sale of tickets. It was regularly moved and seconded that he should be tendered 50% of the net receipts or a maximum of \$25.00. The motion was carried.

Mr. Fennel presented some information from several sources about the future possibilities of the three locations we have been considering as sanctuaries. The Conservation Committee will receive and use this material and hopes to have something to report in the near future.

There will be a report on the budget at the December meeting.

The Merchandising Committee reported a very satisfactory return of \$14.00 from the sale of Note Paper etc. at the membership meeting.
