Sept. 16, 1957.

The regular meeting of the Directors, Officers and Chairmen of Standing Committees, held at the home of Mr. and Mrs. Malone, was called to order at 8:25 P. M.

The minutes of the meetings of May 2 and June 6 were read and approved as corrected.

The Treasurer reported as of August 31, \$133.47 In the general fund and \$169.77 in the Scholarship and Education Fund for a total balance of \$303.24. The report was approved. The President and the Chairmen of the Board reported that after some further consideration the \$50.00 legal fee was judged to be reasonable and the Treasurer had paid the bill. The payment appears on the approved Treas. Report.

The President then read over the proposed program for the coming year and there was general approval demonstrated by the short discussion which followed.


